## The Study

The Shire of Wyndham East Kimberley commissioned CATALYSE<sup>®</sup> to conduct an independent MARKYT<sup>®</sup> Community Scorecard.

The Shire arranged delivery of scorecards to all PO Boxes and provided supporting promotions through Shire communication channels.

CATALYSE<sup>®</sup> sent email invitations to all customer contacts in the Shire's customer databases.

The scorecard was open from 29 January to 16 February 2024.




The scorecard was completed by **570 community members** with various connections to the Shire:






















### Community Action Plan Community safety and crime prevention

### **Community driven actions**

#### **Community Voices**

"Consequences for committing crime, the justice system needs to support the work the police do."

"Lobby the magistrates who live in the communities they serve prior to their appointments, so they truly understand the impacts the lack of consequences has on a community."

> "Working with police, community groups, government departments. Courts and groups being accountable for the actions and decision making. Safe environments for children. Places for the homeless to go and feel safe."

"Get local Aboriginal elders/people involved and actually spend money to support them to have kids moved, punished or supported to clean up town if crime is committed, vandalised etc- have a community response instead of waiting on courts/ govt agencies to facilitate change and consequences."

> 'Management of children in high-risk households to prevent the cycle of substance abuse and violence that leads to trauma."

"Engaging local youth and programs to help families with troubled youth or suffering from misuse of alcohol and other drugs."

"Youth wandering the streets at all hours need somewhere else to go to escape the troubles at home. The street isn't that place. They are bored and resort to crimes to pass the time, creating damage to the town's assets and appearance. Programs at night where they can go play sport or get food and sleep safely is required."

"More security at public places, Coles needs security every hour it is open. Not allowing gathering of people drinking in public places such as White Gum Park which results in smashed glass everywhere making it unsafe for general public, kids and animals etc."

"Night patrols and a safe place for youth. Private security patrols in known hot spots."

"Street lighting needs to be everywhere including parks (Barding Loop). CCTV Footage. Security patrols through town and lakeside"

"Get kids and youth off the streets between 10pm and 6am unless valid reason."



- Lobby the state government to take a stronger stance on law enforcement and punishment.
- Advocate for a greater police presence and more collaboration between the police, Aboriginal elders, community support groups and the court system.
- Provide improved health and wellbeing support for families in need including parenting support, social housing, education and rehabilitation services.
- Engage with at-risk youth by providing activities, counselling, training programs and safe spaces to gather.
- Provide more security patrols to address anti-social behaviour, graffiti, vandalism, loitering and petty crime.
- Provide improved lighting and CCTV cameras in streets, parks and known hotspots.
- Consider introducing curfews for children.

## Community Action Plan

### **Community driven actions**

### **Community Voices**

"Road resealing not temp patches. Safety. Security of the town for tourists and locals."

"Local roads. Long term solutions to fix washed away roads, potholes and sink holes that don't need yearly patching."

"Working with state government and look for grants to put in improved drainage to fix the roads around town - the Hibiscus Rd, Weaber Plain Rd are absolutely atrocious and need better drainage to cope with the seasonal impacts."

> "Better roads. Lines on roads, re-doing roads with a better material which does not wash away after one storm, or better drainage to reduce this damage."

"Raise the causeway on Crossing Falls Road as it usually presents water to drive through in the wet season. No middle white line is also unsafe. Should we wait until a fatality occurs?"

> "Potholes fixed, Lines clearly marked and lighting on the corner of Bloodwood and Ivanhoe roads."

"Local roads. Some are in a terrible state. Seems like small, temporary fixes are applied but these don't fix underlying problems. Greater budget allocation towards local roads."

> "There are a lot of major roads within the shire that need a lot of attention back when the roads were constructed, they were not built for today's transport which is only getting bigger and heavier."

"Parry Creek Road needs a lot more attention with grading in the dry. Drainage needs to be sorted for water crossings so locals can access waterfalls during the wet. The main Valentine water crossing should have depth markers so people don't cross when high leading to the roads closing. An option should be looked at for paving most of this area to allow locals into the main waterfalls more."



- Repair and maintain all roads to a high standard to make them safe for use by locals and tourists. In particular:
  - o repair potholes;
  - o repair kerbs and edges;
  - o improve drainage to cope with storms and floods;
  - o seal heavy-traffic gravel roads; and,
  - o provide clear line markings.
- Carry out all work to a high standard as a long-term solution, not a temporary patch.
- Improve safety of water crossings better drainage, markings and depth indicators.

### Community Action Plan Housing

### **Community driven actions**

### **Community Voices**

"Just more houses, wherever the Council can influence this. Without affordable housing, people won't come to the area for work, which means that services cannot be provided, which means fewer people want to come to the area etc."

> "Facilitate affordable land release and become involved in the construction of affordable housing."

"Make building easier and give more permits for residential building with less hoops to jump through."

"Innovative housing strategies and joint ventures / investment to attract workers, particularly early childhood. Building incentives for new homes, such as waivers and building approval reductions of red tape."

> "Make it easier to build on large blocks - more than one dwelling. Relax the building rules as long as they are safe."

"Innovative housing development models need to be implemented but in parallel, private property owners could be incentivised through subsidised rates as an example (gap to be filled by State or Federal funding) to make more housing available in the town."

> "Ensure those who own vacant land have to build within a certain timeframe, develop a strategy to get private investors to build."

"More housing is needed. Access to cheaper and easier building options. Rent price management is needed."

"An in-depth analysis of all public and privately owned property in town is required to understand how best to activate the many empty houses and vacant blocks of land to ensure that more housing becomes available."

"The state government housing model needs a makeover to ensure that no department has empty houses if another department needs them. All departments need to be treated as one. Crazy situation if the police cannot house employees whilst the Dept of Education has six empty houses that are not currently needed."

"Department of Communities need to pull their finger out and manage their tenants and properties. More affordable houses needed for workers in the region."

"Dealing with the problem houses - Lemonwood/Flametree area has been a mess for years! Needs to be dealt with."



- Increase housing supply to create more affordable housing options:
  - Unlock housing capacity through releasing land;
  - Be more flexible with housing approvals reduce red tape; and,
  - Advocate for state government funding to encourage developers to build more houses.
- Identify vacant land and buildings and provide incentives for owners to lease them affordably an/or develop for housing.
- · Ensure State-owned properties are fully tenanted.
- Advocate for more social housing for vulnerable people of the community including seniors and young people.
- Advocate for Department of Communities to maintain and repair their properties and manage problem tenants.

### Community Action Plan Kununurra town centre

### **Community driven actions**

### **Community Voices**

"Kununurra town centre is the same as it has been for 30 years. It needs cleaning up, streetscaping, plants, gardens and maintenance. It is untidy, dirty and shabby and a very bad look for visitors to our town and region."

"Town is covered in graffiti, glass everywhere and rubbish too. Town centre and especially Coles area is not a nice place to go to on a regular basis. Visitors to our area must find it very confronting to visit our town centre."

"The shop owners need to be pressurised to keep on top of the graffiti. I used to work at a shop in the centre and we cleaned up the outside of the shop every day so there's no excuse."

"Pressure owner of Coles shopping complex to upgrade facilities, car park."

"Have a better shopping complex, better parking, increase livability, clean up town, make it presentable compared to other towns."

"The Shire needs lobby state government for significantly increased financial support for the town and region. Broome has been so much more successful in attracting state government funds for infrastructure improvements."

"A designated town centre between the PO and Visitors Centre on both sides of the road with cafes, restaurants, and an undercover meeting area and decent maintained toilets + cameras and lighting, maybe block off a section. Footpaths, trees, seats."

"Town centre needs a focus. Imaginative plan and vision is needed, along with a commitment from business. Broome provided a case study where a single vision embraced by business has resulted in town centre revitalisation. It's what Kununurra needs."

'I feel like the town is to spread out. A better layout would be a single main street/area with the cafes restaurants/takeaways and small shops etc. Would make it more friendly for walking and exploring and making it easier for people to know their options."

"Kununurra town centre. How about more progressive outlooks / approaches on revitalising our town centre, shire. Lots of potential. Let's see the 'Legacy' mentality mothballed with regards to the excessively hard to please food and planning applications. More markets. More night life. More fresh businesses, hospitality style. It's hard to set up a business here."

> "Incentives for businesses or pop-up businesses to open in the centre of town. Tidy Town initiative as above."



- Clean up and beautify Kununurra town centre, especially around the main shopping centre. Suggestions include:
  - o removing graffiti;
  - encouraging landlords to clean and maintain shopfronts;
  - o planting trees and gardens;
  - o providing more parking;
  - o cleaning and maintaining public toilets.
- Develop a town centre precinct with alfresco dining, cafés and restaurants, pedestrian access and associated amenities.
- Reduce red tape for new business and provide incentives to attract a range of small businesses to the town.

### Community Action Plan Youth services and facilities

### **Community driven actions**

### **Community Voices**

"A safe place for youth to go at night instead of them walking the streets."

"A safe place with food, shelter, effective appropriate understanding adult support, and activities. Overnight - from 8pm till 8am. Plenty of supported, well paid staff to prevent burnout and create a healing nurturing environment for all. This is a job for an exceptionally skilled cohesive (and diverse) team."

"Crisis accommodation for children and young people at risk, especially a safe space (overnight) to help at-risk youth roaming Kununurra streets at night. Night patrol and local police pick up children from the street. If no responsible adult home, there is nowhere to drop them. We need a better response and a more holistic approach, which would in turn reduce youth crime. It takes up a lot of our time and resources trying to identify safe places and responsible people to look after / care for kids. Meanwhile, concerns for community safety and crime are increasing."

"More services to engage young people, to mentor and guide and give them hope and direction. Employment opportunities, upskilling opportunities. Giving them dreams, aspirations and role models so they are able to see a life other than they currently lead."

"Educational and Vocational Training Programs: Partner with local businesses, educational institutions, and vocational training providers to offer workshops, courses, and apprenticeships. These programs can help equip young people with the skills and qualifications needed for employment or further education, with a focus on industries relevant to the Kimberley region."

"Involving youth in community development to ensure ownership and respect of community."

"Cultural and Environmental Programs: Develop programs that allow young people to connect with their cultural heritage and the environment. This could involve activities that promote Indigenous knowledge, land care, environmental conservation, and cultural exchange."

"Increase youth engagement and activities. Improve facilities so that young people can access safely (ie. removing glass off basketball courts)."

"We need things for teens to do. Skating rink. Movie theatre. Improved skate park"

• Provide safe houses with overnight shelter and support services for at-risk youth.

- Partner with local businesses and educational institutions to provide mentoring, career advice and learning opportunities for young people.
- Provide programs and activities to engage young people with their community, culture and environment.
- Provide dedicated centres for young people to gather and socialise with a range of activities and support services available.
- Provide more recreation and outdoor facilities for young people including basketball courts, skate parks, movie theatres, etc.

### Community Action Plan Health and community services

### **Community driven actions**

#### **Community Voices**

"Other towns have mandatory bulk billing for doctors offices if there isn't already one in town. As our town stands now if you want to make an appointment at a GP it's gonna cost."

"We need to be able to access doctors and specialists like physiotherapists and podiatrists. The Shire should have an attractive offer to get these services available. Waiting 4 weeks for a doctor's appointment is not workable. We also shouldn't have to drive to Katherine or fly to Darwin/Perth just to see a podiatrist."

"Diversify health facilities to include secondary health services, such as chiropractic, physio, podiatry, orthodontic, etc., for those to access who work extended seasons in the East Kimberley. Link to Medibank and other private health providers for rebates.

> "More health infrastructure and workforce to manage chronic conditions prevalent in the community. Improved access to Mental Health support, particularly in the drug and alcohol space."

"Greater support for people with drug and alcohol dependence. Shire should have a health plan that engages with service providers to set out the community needs and advocates for them."

> "Health and community services. Incentivise health professional to live here longer with housing."

"More incentives and quality housing for doctors and medical staff. It takes 4 months to see a GP if you're non-Indigenous."

"Kununurra hospital doesn't have all scanning facilities and doesn't do blood test for major things, they only collect the blood and send down to Perth. It takes at least two weeks to get the results. For example: if we doing IVF we need the blood test results on the same day which is not possible with Kununurra hospital for single blood test we need to travel to Darwin or Perth which requires a lot of time and money. It would be great if we focus more into health facilities."

"Stop the reducing of health services at the Kununurra Hospital. Make it a hospital again and not just an emergency centre. Re-open Wyndham Hospital."

"Wyndham has a glorified clinic... seriously we need doctors and nurses here for our sick people, not being told that we have to go to Kununurra because there are no doctors available."



- Advocate for funding to provide more health care services throughout the Shire, to reduce wait times and the need to travel for treatment. Specific mentions include:
  - o more permanent GPs (particularly bulk-billing);
  - o a range of specialists;
  - allied health services (physios, chiropractors, podiatrists etc);
  - o mental health and drug and alcohol support.
- Provide incentives to attract and retain health professionals (eg housing).
- Advocate for funding to expand services at Kununurra Hospital.
- Advocate for funding to expand medical facilities in Wyndham.

### Community Action Plan Family / children services and facilities

### **Community driven actions**

### **Community Voices**

"The Shire needs to work with government to increase childcare places in Kununurra. Good families are leaving town because they cannot access childcare. And good families are avoiding moving to town for the same reason. I know one amazing teacher who can only teach one a day a week because her young child is 52nd on the Ewin Centre wait list."

> "Daycare needs to be functioning as a Shire-owned service in order to meet the needs of working families in town."

"Help working families access after school and holiday care by supporting local providers."

"After school and school holiday programs. More sport options and group fitness classes at the Rec Centre."

"Provide subsidised housing for employees of local childcare facilities to assist in recruitment of staff."

"Establish family support centers or services that provide counselling, parenting workshops, and resources to assist families in need."

"The Shire should be investing in social programs that can support families and individuals to work through the key issues at play in the East Kimberley, such as addictions, domestic and family violence, child neglect, school attendance, relief housing. These are all very pressing issues that need lots of attention. The Shire should be looking to become a leader in tackling these issues and at the moment I don't see anything that makes me think this is a priority for the Shire."

"The current parks are very out-dated and poorly maintained. Development of spaces for young families in all areas of town including out of town estates to allow for networking within the community and enhancing quality of life for families with young children."

"Maintain parks and playgrounds better by cleaning the areas. Playgrounds need to be pressure cleaned from time to time and rubbish collected frequently. Need more shade and up to date playgrounds that are maintained."



## Advocate for funding and support for more child-care facilities.

- Provide before and after-school and holiday care and activity programs.
- Provide incentives to attract high quality child-care workers (eg subsidised housing).
- Provide family support services with counselling, workshops and resources to assist families in need.
- Improve parks and playground facilities for children and families – keep them clean and well-maintained, provide shade and amenities.
