### PURPOSE

---

For Council to accept the Annual Report for 2023/24 and to set the date for the Annual General Meeting of Electors.

## **BACKGROUND / PREVIOUS CONSIDERATIONS BY COUNCIL OR COMMITTEE**

---

The Annual Report for the period 1 July 2023 to the 30 June 2024 has been prepared in line with the *Local Government Act 1995* and summarises that year's achievements and challenges, as well as addressing stipulated statutory requirements. The Annual Report also demonstrates performance against the Shire's Strategic Community Plan 2023-33. The Annual Report includes the Audited Annual Financial Report for the year ended 30 June 2023, which has been certified by the Office of the Auditor General. The Annual Report also includes the Auditor's Report stating that the financial statements contained in the report are in accordance with the *Local Government Act 1995* and the Australian Accounting Standards.

## **COMMENTS**

---

The Annual Report provides a summary of achievement against stated Council actions as well as comprehensive review of its financial performance and is recommended to be accepted by Council. It has also been prepared in line with relevant legislative requirements and the report of the auditor meets the requirements of the *Local Government (Audit) Regulations*.

Council is required to convene the Annual General Meeting of Electors no later than 56 days after the report's acceptance, being no later than 12th February 2025. To allow for statutory notice periods the meeting must be held after 24th December 2024. It is recommended that Council convene the Annual General Meeting of Electors on Monday 10th February 2025 to allow Council and community time to return to the East Kimberley following the Christmas break.

## **STATUTORY IMPLICATIONS**

---

The *Local Government Act 1995 section 5.54(1)* requires the Shire to accept the Annual Report for a financial year no later than 31 December after the end of that financial year. The Shire is required to then hold a meeting of electors (Annual General Meeting of Electors) no later than 56 days after acceptance of the Annual Report (*section 5.27(2)*). If the auditor's report is not available in time for the annual report for a financial year to be accepted by 31 December after that financial year, the annual report is to be accepted by the local government no later than 2 months after the auditor's report becomes available.

The *Local Government (Audit) Regulations* are relevant to the report of the auditor which is included in the Annual Report at page 113 of the Annual Report.

The *Local Government Amendment (Auditing) Act 2017* gives the Auditor General the mandate to audit the Shire's Annual Financial Statements and Associated Notes. The Annual Financial Statements and associated notes contained within the Annual Report has been audited by the Auditor General. This can be found from page 86 of the report.

The *State Records Act 2000* requires that the Shire include a statement on the compliance with the Shire's Record Keeping Plan. This can be found on page 35 of the report.

The *Disability Services Act 1993* requires the Shire to include a statement on the compliance with the Shire's Disability Access and Inclusion Plan. This can be found on page 53 of the report.

The *Freedom of Information Act 1992* requires the Shire to include a statement on the process for applying for information under the Act. This can be found on page 35 of the report.

### PURPOSE

---

For Council to consider endorsing the naming of the Kununurra Agricultural Oval the "Ingrid Harvey Oval" in honour of Ingrid Harvey, a long-standing and highly respected resident who recently passed away. Noting that to officially recognise the naming of the Oval through Landgate, Shire Officers will first need to apply and meet the policy requirements outlined within the Commemorative Naming Policy.

And for Council to endorse a budget allocation of \$5000 so Shire Officers can install suitable signage at the Oval which highlights Ingrid's commitment to volunteering and community sport but also acknowledges the Kununurra Agricultural Society contribution to establishing the oval in the late 1990's.

## **BACKGROUND / PREVIOUS CONSIDERATIONS BY COUNCIL OR COMMITTEE**

---

Ingrid Harvey was a well-known and deeply respected member of the East Kimberley community, whose contributions to sport, youth development, and community volunteering have left an enduring legacy. Sadly, Ingrid passed away on October 20, 2024.

Ingrid moved to the region from Darwin when she was just two years old. As a young girl and woman, she was a superb athlete and sportswoman. Many who knew her believe that if she were young today, she would likely have represented Australia in one sport or another.

Although her playing days were cut short by injury, Ingrid transitioned her passion for sport into coaching, youth talent development, and active service on several sporting committees. She played a pivotal role in establishing sports such as softball, basketball, and the Ord River Magpies Football Club. Ingrid held life memberships in softball, basketball, the East Kimberley Football League (EKFL), and the Ord River Magpies Football Club.

The Ord River Magpies Football Club honours Ingrid's legacy through an annual Club Person of the Year award named in her recognition, celebrating extraordinary contributions by members. She was also awarded a medal from the Western Australian Football Commission for her service to football and was twice named Kununurra's Citizen of the Year.

Ingrid served as Secretary of the Ord River Magpies Football Club for 25 consecutive years (1995 to 2020) and spent the last four years of her life as Vice President.

There has been strong support from the Kununurra community for Council to consider naming the Kununurra Agricultural Oval after Ingrid. While Shire officers agree that her significant contributions to community sport warrant recognition, Council should also consider the historical connection of the Kununurra Agricultural Society to the site.

The Kununurra Agricultural Society holds a lease over the surrounding area of the oval and has a long-standing connection to it. Members of the society and the broader community were instrumental in helping the Shire establish the oval approximately 23 years ago.

The oval development was a collaborative effort between Kununurra Agricultural Society, the Shire of Wyndham East Kimberley, and the Department of Sport & Recreation. Each party funded approximately \$50,000 to construct the oval. In addition to this, the Kununurra Agricultural Society provided enormous amounts of in-kind support, including laser levelling of the oval, cost price materials and equipment for irrigation and hundreds of hours of volunteer labour.

While the oval was never officially named, it has long been referred to as the "Ag Oval" in recognition of this historical significance.

## **COMMENTS**

---

Ingrid Harvey is widely recognised for her remarkable contributions to volunteerism, and community sport, particularly through her involvement with the East Kimberley Football League, the Ord River Magpies Football Club, and her efforts in developing basketball and tee-ball/softball in the region. As a dedicated and prolific volunteer across many sports, Ingrid's impact extends far beyond her achievements. She was a unifying figure whose tireless efforts strengthened community bonds and created opportunities for countless individuals.

Ingrid Harvey's involvement in sport has strong ties to the Kununurra Agricultural Oval. As the Ord River Magpies Football Club grew in prominence and established their clubrooms at the oval in the early 2000s, Ingrid played a pivotal role in fostering the development of the club. Her dedication extended to coaching, administration, and youth development, where her influence shaped the lives of many in the community.

Naming the Kununurra Agricultural Oval in her honour would serve as a lasting tribute to her invaluable contributions, ensuring her legacy is permanently recognised. This gesture would also demonstrate the Shire's commitment to valuing decades of volunteering and dedication to the community.

In addition, it is essential to acknowledge the Kununurra Agricultural Society's significant role in the history of the oval. The Society was instrumental in leading the project to establish and formalise the oval in the 1990s, creating an invaluable community asset. Any signage installed as part of this renaming should reflect both Ingrid's contributions to community sport and the Agricultural Society's involvement in the oval's establishment. This approach ensures that the history of the site and its foundational contributions are preserved alongside the recognition of Ingrid Harvey's remarkable legacy.

Should Council endorse the Shire Officers' recommendations, a public function to officially name the oval will be arranged as a priority. The timing of the event will also depend on the availability of Ingrid's family, who reside outside the region.

## **STATUTORY IMPLICATIONS**

Kununurra Pool Maintenance budget. Currently, \$29,857 remains in this budget, which is unlikely to be utilised due to the Kununurra Leisure Centre Pool being closed for construction.
